## **Our Values**





#### I would like to welcome you to the 2023 Annual Report which is Kerry Parents & Friends Association's 50th Anniversary year.

In 1973 Kerry Parents & Friends Association was established. Over the following 12 months more than 30 branches and committees were set up throughout Co. Kerry. The first branch committee was formed in Rathmore on 24th September 1973. Its purpose was to raise funds to support adults with intellectual disabilities (ID) in the locality. Our first house, Mount Eagle Lodge, was purchased in Tralee in 1978 to provide a residential service for 10 adults. In 1984, Fr. Corridan Centre was opened and throughout the 80's KPFA restored the Old Monastery in Killarney to become its Headquarters (HQ).

The highlight of 2023 was KPFA's celebrations to mark its golden jubilee. Official events took place in, Tralee, Killarney and Rathmore to mark this special occasion, with local events in Listowel and Castleisland.

To commence our 50th celebrations a new centre was officially opened in March in the Fabric Building in Tralee. A special gathering for all involved in KPFA was held in the Old Monastery in Killarney in June. At this fun and entertainment event, the new Sensory Garden was officially opened. In September there was an open invitation to the community in Rathmore to attend an anniversary celebration mass with an after celebration in Tearmann Lodge, one of our residential Centres. The celebrations marked a very special milestone for the Association, the Rathmore Branch and the community.

Over half a century, the Association has gone countywide. On page 46 of this report there is an overview of the present KPFA. On the foundation laid down by our founding members we will continue to improve, expand and extend our services to meet the needs of the people we support and their families into the future.

2023 proved to be another challenging year for the Association. There were ongoing difficulties with the Pandemic, Inflation, Pay and Pensions, Staffing and Retention. Funding is a major issue of concern. We receive 95% of our income from the HSE. Various fundraising activities helped to replace the outstanding 5%. Unfortunately, there has been very limited activity in this area in recent years. KPFA have a deficit of €659,777 this year.

The Board of Directors (BOD) of KPFA is responsible for overseeing the proper management of the organization and to ensure that we operate in compliance with our service arrangement with the HSE and with all regulatory accountability. To the best of my knowledge and belief the Board fulfilled its role in 2023. Traditional board, subcommittee, HSE and HIQA meetings took place on a regular basis. Online meetings were held on Zoom or Teams. The Charities Regulator (CR) has recommended a nine year membership limit as best practice for all Boards. Directors will serve for three years for a maximum of three terms. The Directors of KPFA, past and present, have made a huge voluntary commitment to the organisation. They receive no pay and do not claim expenses. The majority have family and work pressures but are generous with their precious time and skill set. KPFA would welcome nominations for Directorships to increase board numbers.



#### HIQA continue to

acknowledge the quality of care and commitment of the staff in our residential homes. All our residential houses have been inspected and registered by HIQA. KPFA complies with all new directives from HIQA. Every effort was made to retain existing services and supports, in particular respite and residential. The staff in KPFA were more than willing to take on various roles and different duties when the need arose. Their response was exceptional and on behalf of the Board of Directors (BOD) I wish to compliment and congratulate everybody on their tremendous efforts in such difficult circumstances.

The Approved Housing Body Regulatory Authority (AHBRA) has granted recognition to KPFA as an Approved Housing Body. Funding and grants will be available to develop our social housing needs, especially residential, in the future.

In 2023 the BOD, CEO and the Senior Management Team (SMT) have done extensive work reviewing and updating KPFA's company documents, in particular our Constitution and Board Governance Handbook. These have been vetted by our solicitor and legal advisors to ensure compliance with the Charities Regulatory Authority (CRA). Our draft Memorandum & Articles of Association / Constitution is currently being reviewed by the CRA.

Míle buíochas to my fellow Directors, our CEO and Management Team, Centre Managers, our staff and volunteers, your support this year was much appreciated! Thanks to Denis Murphy, Moriarty and Murphy Accountants, for all his financial advice and assistance to the association during the year. A special thanks to a number of staff who retired this year after a life time of service to KPFA.

Finally, on behalf of the Board, I would like to extend sympathy to the families, friends and relatives of all those connected to KPFA who passed away in 2023.

Welcome to our 50th Anniversary Annual Report.

**2023 was challenging** for everyone in many different ways, but as always, we did our level best to weather each storm as it emerged. There were very happy occasions too as evidenced in this report and Kerry Parents & Friends Association (KPFA) concentrated on the positives while dealing with the negatives in the background. Our focus has always been one of doing our best for the people we support and as long as we maintain that purpose, going forward, we cannot go far wrong.

As we reflect upon the challenges encountered in 2023, KPFA acknowledges the **impact of an ongoing deficit**, compounded by the unpredictability of sporadic **Covid-19** outbreaks and a severe **staffing crisis**. These unprecedented times have tested our organisational resilience, revealing the depth of our commitment to the people we serve.

The persistent **threat of Covid-19**, marked by sporadic outbreaks, added an additional layer of complexity to our operations. The need for adaptability and vigilance remained a cornerstone of our approach as we navigated through the uncertainties presented by the ongoing pandemic.

Equally challenging has been the **severe staffing crisis** we faced throughout 2023. The recruitment landscape has proven to be a formidable terrain to traverse. Despite this hurdle, our commitment to delivering essential services remained resolute and our staff did everything possible to ensure that, often at a cost to their own family time. We recognize the importance of a dedicated and motivated team, and all efforts were underway to address staffing challenges through innovative recruitment strategies. KPFA deeply appreciates the goodwill of our dedicated staff, without them, our services would have been severely curtailed during 2023. Sincere thanks to all!

2023 also brought celebration as KPFA turned 50! The Fabrik Centre in Tralee opened its doors for an engaging Open Day on 25th March, offering visitors a first-hand experience of creativity and innovation. This Tralee Hub was officially opened by Tralee Lions Club's Finbarr O'Connell, who's club has supported KPFA's Tralee Services for over 30 years. He was ably assisted by JJ O'Shea, who has availed of services also for over 30 years. The Centre was blessed by Fr. Gregory Carroll of the nearby Dominican Church. Following the speeches by Hugh Ryan, Chair Board of Directors, Fr. Carroll and Marie Linehan CEO, the crowd settled in to lovely food, music and dancing provided by Mike O'Shea and Mikey and Ann McAuliffe. Thanks to everyone who made this day such a success, especially to our volunteers, our KPFA Operations and Maintenance and Tralee Services Teams.

Killarney, The Old In Monastery hosted а lively one-day festival to celebrate KPFA's 50 vears on Saturday 24th June, attracting locals and visitors alike. Thanks to a large donation by Lara O'Brien, who won €23,554.92 on Today FM and donated half of it to KPFA, the KPFA team about organising set their biggest community event as a "Thank You" to everyone who supported



it over the 50 years of its existence. The event showcased a diverse range of performances by the Kelleher Family, Truly Diverse, The Singing Jarvey and our very own Biddies and was hosted by Niall Botty O'Callaghan. The day featured craft stalls, fun activities, and culinary delights, creating a festive atmosphere within the historical setting of The Old Monastery. The newest addition to the Old Monastery, the sensory garden, was officially opened by Jacinta O'Callaghan, who served as Centre Manager of the Killarney Day Services for 33 years. KPFA is very grateful to everyone who contributed to the success of the event from start to finish. Our Operations Team, staff and volunteers (too numerous to mention) played a pivotal role in organising this momentous event. Thank you all!

St. Joseph's Church in Rathmore provided the sacred backdrop for a special Mass commemorating a significant occasion on 24th September, 50 years to the day that the Rathmore Branch was formed. The Mass was concelebrated by our Patron, Most Rev. Ray Browne, Bishop of Kerry and Fr. Pat O'Donnell, Parish Priest of Rathmore. Our very own Gerard Horgan provided stellar singing, assisted by the local choir and musical director, Maura O'Leary. The Mass was hailed as one of the most beautiful in recent years. Following the Mass, the community gathered at Tearmann Lodge for refreshments and music, fostering a sense of togetherness and celebration. Michael John Dinneen (retired Branch & County Chair KPFA) and Tony Darmody (retired CEO) cut the cake. Michael John made a heartfelt speech to the gathering, as did Bishop Ray Browne and Marie Linehan CEO, thanking the community, the local branch who would welcome new recruits and the Panto Group, Marian Players, who has supported the Rathmore Services for more than 34 years. I look forward to witnessing the continued growth and success of KPFA under new leadership, from March 2024. Sadly, KPFA has lost many friends during 2023 and we dedicate a special page to them in this report. We extend our sincere sympathies to all families, supporters, volunteers and staff who have lost loved ones during 2023. Saying goodbye is never easy, but we take solace in the fond memories we have been left with and smile as we remember.

Finally, as we confront a daunting deficit going into 2024, a stark reminder of the fiscal hurdles we must overcome and, in the wake of this financial strain, strategic financial management and resource allocation will be pivotal to ensure the sustainability of our organisation. We stand resilient in the face of financial adversity, the unpredictable nature of the ongoing pandemic, and the staffing crisis. We extend our gratitude to our supporters, stakeholders including HSE Cork Kerry, and the community for their continued trust and understanding during these trying times. We will prevail with resilience, strength, and the bonds of friendship and support that endure even in the face of adversity.

AS ITS 50th year in the community, 2023 marks another milestone for the Kerry Parents and Friends Association and last weekend the organisation celebrated yet another landmark moment with the opening of its new centre in Tralee.

explained that KPFA was first established in 1973 by a committee who wanted to do what they could to help families of people with in-tellectual disabilities. They started out by fundraising for St Mary of the Angels in Beaufort, Killarney and over the following 12 months, they set up more than 30 branches and committees throughout Kerry.

By 1978, it was clear that a service for young adults with disabilities was ur-gently required in Kerry and it was agreed that Kerry Parents and Friends Association would provide that service by developing a residential service for 10 young adults in Tralee.

"And so, KPFA became a service provider in its own right, continuing to fund-raise through its branches to set up this new service and it bought Mount Eagle Lodge in Oakpark, Tralee that same year," Marie explained.

The rest, as they say, is history and today, through community support in Ker-ry and abroad, and the support from its network of branches, from local businesses, sporting fields, and

statutory agencies, KPFA now operates 30 Day, Res-idential and Respite Centres, along with Home Support and Outreach services across the county.

Marking the milestone of the organisation's 50th year in local communities, last Saturday was a day of huge celebrations - the first of a series of events lined up to mark this landmark year. Tralee Lions Club's Finbarr O'Connell, who has supported KPFA's Tralee Service for more than 30 years, cut the ribbon at the official opening and the new centre was blessed by. Fr Gregory Carroll of the Dominican Church.

As the celebrations of KP-FA's 50 years in the com-munity continues, Maire said: "The next event is a said: "The next event is a gathering of invited guests, people we support, families and friends, staff and for-mer staff, directors past and present to celebrate our 50th year and incorporat-ing the official opening of the Sensory Garden, at The Old Monastery, Port Road, Killarney. 



## Origin and Development of The Marian Players, Rathmore.

The Marian Players Group was formed as a result of discussions on how best to provide financial support to KPFA in addition to the very successful Sale of Work which was already bringing in a five figure sum each December exclusively for KPFA. In September 1987 Val Moynihan was invited by their chairman, Hugh Ryan to attend the branch's monthly meeting on September 3rd where this topic was on the agenda. It was agreed at that meeting that the branch members, with the help of others would support an effort to stage a pantomime for fund raising purposes and the branch would also see to providing seed money to cover the initial expenses and also cover the activities in the event of a disastrous outcome. On the suggestion of Fr Jim McElligot it was agreed to title the group 'The Marian Players'. The group was to be a voluntary group whose principle activity was to stage annual pantomimes in the area to benefit community life as a local activity, and support Kerry Parents and Friends as a fundraiser. The Rathmore branch members of Kerry Parents and Friends would form the support structure for the project, and that Michael John Dinneen, the County Chairman of Kerry Parents and Friends, would also be chairman of the Marian Players. Val Moynihan was to take on the role of organising a cast and the group.

The Marian Players' shows and any other ancillary activities e.g. back stage and front of house etc., including preparation works are indemnified by The Kerry Parents and Friends Association insurance to help increase the donation returned to KPFA. Members of the Marian Players would therefore be de facto temporary members of Kerry Parents and Friends on a year to year basis. With Michael John Dinneen as chairman, Margaret Hickey as secretary, Mary O'Connell as treasurer and Eilish Coakley Asst. Treasurer, Val Moynihan's role was to organise the shows.

Both committees (KPFA Branch and The Marian Players) maintained very close relationship so as to maximise efficiencies and avoid incurring unnecessary debts. In line with the mood and practice in running the Sale of Work the group developed a voluntary ethos in its approach and attitude in carrying out day to day functions, which not only build camaraderie among members, but also added very significantly to the bottom line at year end. Voluntary, in a similar fashion, was the key word in terms of approach and activity, with all sectors, not just the performing roles, which were supported willingly from the very beginning thus developing a team with skill and unity of purpose. Community was also to be the key in establishing success i.e. a community within the group and beyond, and a community in the midst of local communities.

#### Kerry Parents & Friends Association DIRECTORS' REPORT

for the financial year ended 31 December 2023

The directors present their report and the audited financial statements for the financial year ended 31 December 2023.

#### Principal Activity and Review of the Business

The principal activity of the company are providing services and support to persons with an intellectual disability and their families throughout Kerry. Revenue funding is primarily sourced from the Health Service Executive - Southern Region (previously Southern Health Board). Other revenue includes the collection of statutory charges. Capital funding is primarily sourced from fundraising, government capital grants and donations.

In the financial year under review, income increased from €15,803,214 in 2022 to €16,943,644 due mainly to funding from the HSE for existing commitments, as well as emergency care needs and respite care services and once off building/maintenance works. Grant income was also received from Kerry County Council and Rethink Ireland for various once-off projects.

We would like to avail of this opportunity to thank the granting authorities and the following organisations without whose support we would not be able to function and we look forward to working with them in the future.

#### Objectives

Kerry Parents & Friends Association provides services to adults with an intellectual disability. This is facilitated through the provision of day services, residential and respite services.

The principal objectives of the Association is to deliver services and supports relating to needs, wishes and choices of people with intellectual disability, based on their communities and connected to natural support networks.

#### Structure

Kerry Parents & Friends Association is a company limited by guarantee not having a share capital incorporated in Ireland in 1986 under the Companies Act and is registered with the CRO registration number 112184.

#### Governance

Kerry Parents & Friends Association is a registered charity CHY 6871, governed by a Board of Directors who come from various professional and other backgrounds, drawn from the community. The Board maintains the legal, financial, professional and ethical standards of Kerry Parents & Friends Association. The Board has implemented "The Charities Governance Code". The Associations Charity Regulator's number is 20013752.

The Board gives of their time to Kerry Parents & Friends Association on a voluntary basis and receives no remuneration. The Board ensures the activities of the Association are consistent with its charitable objectives. There are clear distinctions between the roles of the Board of Directors and Key Management Personnel, to which day to day management is delegated. Pay and remuneration of the charities key management personnel is set in accordance with HSE pay scales.

#### Mission Statement

The mission statement of Kerry Parents & Friends Association is : "To deliver life enhancing services and supports responding to the needs, wishes and choices of people with intellectual disability, connect to support networks in their community".

#### **Principal Risks and Uncertainties**

Kerry Parents & Friends Association operates as a distinct legal entity and is obliged to run its business in conformity with best practice within its regulatory environment. On an operational basis, it needs to attract and retain the right level, mix and calibre of staff in order to render a quality service to its clients up to the expected standards in its service provision sector.

The Association provides services under contract to the HSE and is dependent on State Agencies and voluntary contributions for funds and any curtailment in either source of funding could have a significant impact on its services.

As an employer and owner/occupier of properties, Kerry Parents & Friends Association needs to comply with the onerous standards set down in the Safety, Health and Welfare Act 2005, with the national Standards for Residential Services (monitored by HIQA) and with all associated employer liability and public liability requirements.

The Association mitigates these risks as follows :

#### Financial risks

The company continually monitors the level of activity, prepares and monitors its projections and cashflow forecasts.
 Financial information is subject to detailed review at board level allowing for continuous monitoring of the company's operations and financial position.

#### Operational & Internal control risk

- The risk is minimised by the implementation of procedures for authorisation of transactions and the requirements for budgets covering all activities.

- Procedures are in place to ensure compliance with Covid-19 restrictions and with health and safety legislation to protect staff, people supported and service providers.

#### Reputational and Compliance risk

- In common with many charities, the company's principal risk is reputational damage. Reputation damage could be caused by an event either within or outside the company's control. In order to mitigate the risk, the company continues to adapt best practices.

- The company closely monitors emerging changes in regulations and legislations on an on-going basis by ensuring all accreditations are up to date.

#### **Financial Results**

The (deficit)/surplus for the financial year after providing for depreciation amounted to €(659,777) (2022 - €237,860).

At the end of the financial year, the company has assets of  $\in 10, 161, 209 (2022 - \in 10, 585, 433)$  and liabilities of  $\in 4, 657, 038 (2022 - \in 4, 421, 485)$ . The net assets of the company have decreased by  $\in (659, 777)$ .

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable Irish law and regulations.
